4.13 <u>Developer</u>: "Developer" means the party who creates the Condominium or who offers Condominium parcels for sale or lease in the ordinary course of business, except that the term "Developer" shall not include the owners or lessees of Units in Condominiums who offer the Units for sale or lease of their leasehold interest for assignment when they have acquired or leased their Units for their own occupancy. Waterford Waterfront Building A, LLC, B Guran of Venice, LLC, and Z J Guran of Venice, LLC, all Florida limited liability companyies, are is the Developer of this Condominium, and are is herein referred to as "the Developer."
